SUBJECT: Tactical Decision Making in Wildland Fire

TO: Students

Congratulations, you have been selected to attend Tactical Decision Making in Wildland Fire (formerly S-336), at the Angeles Training and Conference Center (ATCC), January 19th through 22nd, 2016. Class will begin at 1000 on January 19th and will end at approximately 1500 on January 22nd.

Use gate code 5604 at the entrance gate to access the training center.

Parking:

Parking is available in the rear parking lot. Follow the signs posted at the entrance to the compound. **Please do not park next to the main buildings.**

Course Information:

In November of 2015, an executive decision was made by NWCG to discontinue the use of the S-336, Tactical Decision Making in Wildland Fire course. The Angeles Training and Conference Center believes there is value in presenting this course as a supplement to other 300 level courses and will continue to host it without the S-336 course code.

Our cadre will deliver the content of the original course with enhanced lessons-learned and experience-based information relevant to tactical decision making at the strike team and task force leader level. We will maintain all course prerequisites and relevant course resources.

Trainee Prerequisites:

Student must be qualified as a single resource boss or ICT4.

Pre-Course Work:

Attached, you will find the Pre-Course workbook that you will need to read before the start of class. Please bring this with you and be prepared to discuss.

In addition, students will need to bring a hand held radio, IRPG, and copy of their local unit's Incident Organizer worksheet to the course.

Attire:

Students are to wear casual office attire. This means attire suitable for public contact (no shorts, tank tops, flip flops, etc.)

Tuition:

Tuition cost is \$300.00 per student. For non-federal students, tuition will also include an 8% admin fee imposed by the National Finance Center, for a total tuition of \$324.00.

Billing Information:

Forest Service / Other Federal Agencies: The approved NWCG Nomination Form is used for payment. It must include proper agency codes and signatures.

Non Federal Agencies: Students are required to submit the NWCG Nomination Form with signatures to attend the course. A bill of collection will be issued to your agency at the end of the training course. Students who wish to pay the tuition themselves can also be issued a bill of collection.

Cancellations:

Cancellations must be made two weeks prior to the start of the course. If cancellations occur after the two-week cut off, your agency will be charged for tuition.

Lodging:

There is no lodging or food service provided at the Angeles Training and Conference Center. There are numerous options for food and lodging nearby in Arcadia.

Airport:

If you are flying to this session, your destination is Burbank (Bob Hope) Airport.
